WORSHIP TIME MOVING TO 9:30 A.M. - Begins Feb. 9th

Dear Members of the Congregation,

As promised, the Council has been monitoring the success and any concerns about our change in worship time to 9 a.m. as a trial period for the past few months. The positives include more time available for committee meetings after worship, and there is also opportunity for other activities and programs of the church after worship. It appears this works for our music staff and musicians currently. We have heard concerns that some of our members find it a hardship to get to worship services an hour earlier than previously, and were concerned that if choir rehearses at 8 a.m., this is very early to sing, but it is doable.

As a reminder of the steps taken,

1. In August, the Council provided feedback about worship when we became aware Carolyn Gosse would be retiring. It was important to the Council that we provide worship with organ for our members. We began looking for an organist, and found one possibility - sharing the organist from the Methodist Church.
2. The Council voted to try worship service an hour earlier to accommodate the organist we hoped to hire - Emma McKirdy Wilsey. We tried worship at 9 a.m. in September and October, and late October (when Carolyn Gosse retired), the position was offered to Emma.
3. We discovered that the Methodist Church was meeting at 11 a.m. rather than 10:30, but this was a trial period for them as well, and they would decide after Christmas whether they would stay at 11. This gave Emma 30 minutes more time than we originally anticipated.

However, the Council decided to stay with the 9 a.m. trial period for our worship until we were sure about the Methodists. We have learned that their time will remain at 11 a.m.

4. We now are sure of the timing of Emma's commitments on organ. In consulting with Emma about the time she needs to gather her things and get her two young daughters from the nursery and get over to the UMC, she still believes it is possible. 30 minutes is pretty tight, but if we keep our service under an hour it is still possible to share her time.

5. Council decided at their meeting last week that we will move our service to 9:30 a.m. beginning Sunday, February 9. Choir will shift their rehearsal to 8:30 a.m. as well.

We hope this helps you understand that organ and choir music is important in our church, so pursuing an outstanding organist like Emma was important. Organists are difficult to find, and Emma was willing to try this, so the Council moved on it. Decisions made about our music have provided a worship experience that continues the excellence in music that we have been accustomed to.

Thank you for your patience. Remember, we move to **9:30 a.m. on February 9!**
